Request for Proposals: IMPACT at GREEN SPRING STATION

Application Deadline: Saturday, August 15, 2015

Maryland Art Place (MAP) is now accepting applications for its fall 2015 IMPACT project at Green Spring Station. This fall, MAP is partnering with the **Green Spring Station** for an artist or team of artists to create an original temporary indoor installation comprised of items from the merchants of Green Spring Station. Items may include: resistance bands/dumbbells, bras, nighties, pjs, hair products, blow-dryer, dresses, tennis racquets and balls, boxed stationery, journal, guest books, calendars, sample event stationery, children's books, wooden toys, and candy. The resulting sculpture does not need to incorporate all materials.

IMPACT is an annual, public art program developed to extend Maryland Art Place's reach to broader audiences bringing the work of living artists into the public eye. Each IMPACT project is unique and developed based on the partnering site.

Artists are strongly encouraged to visit Green Spring Station prior to submission. The proposed work(s) may not block any of the sidewalks or security measures in place.

Eligibility: This call for proposals is open to all artists residing in the state of Maryland.

**Please note that work should be appropriate for viewers of all ages.

The selected artist/artist team will receive a **\$1,000** stipend to cover the cost of materials and labor. Installation is scheduled to take place between October 1, 2015 and November 13, 2015. MAP and the Green Spring Station will host an opening reception at the site in mid November.

Please send your proposal to impact@mdartplace.org by Midnight August 15, 2015. Along with your application, you are welcome to submit up to 3 images or illustrated sketches. Past installation work samples will also be accepted.

About Green Spring Station: Green Spring Station is a mixed-use center featuring Baltimore's largest collection of locally-owned boutiques, cafes and restaurants.

Green Spring Station is conveniently located at the intersection of I-83 and I-695 at 10803 Falls Road Lutherville, Maryland 21093.

From Baltimore City: Take the Jones Falls Expressway (I-83) North get off at the Falls Road Exit just after Ruxton Road. Go right at the 2nd Traffic light onto Station Drive. From here, follow the Campus Map detail.

From York, Pennsylvania: Take the Harrisburg Expressway (I-83) South which ends at I- 695. Go West on I-695 and get off at the first exit Falls Road North, exit 23 B. Go right at the 2nd Traffic light onto Station Drive. From here, follow the Campus Map detail.

From Towson: Take I-695 West to Exit 23B Falls Road North. Go right at the 2nd Traffic light onto Station Drive. From here, follow the Campus Map detail.

From Pikesville: Take I-695 North to Exit 23B Falls Road North. Go right at the 2nd Traffic light onto Station Drive. From here, follow the Campus Map detail.
